Summer 2021 Journey to New Brunswick Yields a New Loyalist - JAMES TAIT

While visiting my sister in Miramichi, Northumberland Co., New Brunswick, Canada this past summer, we were chatting about our maternal lineage and new possible loyalist ancestors. My sisters, brother and I are



descended from loyalists, both through our paternal and maternal lines and some are ancestors to both our father, Carlyle William Stymiest (1910-1994) and mother, Bessie Winona (TAIT) Stymiest (1912-1980). One example is Loyalist Sgt Philip Hierlihy UEL of the Hierlihy Corps and the Prince of Wales Regiment. Philip Hierlihy is my 4th Great-grandfather through my father's lineage and my 3rd Great-grandfather through my mother's line.

To date, we have located nineteen New Brunswick/Nova Scotia loyalist ancestors and with research have proven twelve to date. However, one maternal loyalist ancestor, James Tait UEL and his wife Janet have eluded our research until now. The only information we had to date was the following.

- That he was born in Scotland, came to Virginia, and served in the 3rd Virginia Regiment during the American Revolution.
- That he had settled in the Sunbury County area on New Brunswick.
- That he had sailed to England to make a Loyalist Claim for Losses in 1784.

But then, Eureka! While searching other New Brunswick loyalists, a new source to where James might be buried surfaced. The information was tucked away in another loyalist's relevant documents, namely, the *WILLIAM JOSEPH HERON* family. The source is a book, authored by Isabel Louise Hill: *The Old Burying Ground, Fredericton, New Brunswick, Vol. III, 1992*. This book is still available from *Google Books* online and is a true legacy of Isabel Louise Hill (1901-1996) devotion to history. She was a devoted librarian, historian, and author of numerous books on the United Empire Loyalists and other founding families of central New Brunswick, Canada.

Note: Related documents regarding the Heron and Tait family connection:

"William H. Heron died 22nd December 1868 in the 70th year of his age. A native of Dumfriesshire, Scotland. Also, his wife Janet, died 17th April 1869 aged 83 years; a brother, J. W. Heron died July 26, 1875, aged 46 year; M.C. Heron died April 29, 1884, aged 64 years. Native of Scotland.

Among the source documented papers, "LIEUTENANT HERON, 74th Regiment, returns his sincere thanks to the inhabitants of Fredericton and its vicinity for their kind exertions in endeavouring to extricate him from his perilous situation, when lost in the woods during the 25th, 26th, and part of the 27th ultimo, and assures them he shall remember their good wishes with gratitude as long as he lives." Barracks. Monday Morning, 30th Nov. 1818.

During 1824, the Heron's had a farm at Heron Lake. The farm was a showplace in its day, and when the Prince of Wales came to New Brunswick in 1860, he was taken to Heron Lake for fishing. After the family had died or left the vicinity, the farm was maintained as a summer hotel for some years. It was renamed the *Killarney House*; *Herons Road* leading to the farm and *Herons Lake* was also renamed *Killarney*."

Another very pertinent document dated September 13, 1886, stated that, "Elizabeth Savage claims for herself, JANET TAIT, and her husband Loyalist JAMES TAIT and their children the right of interment in a lot in the Burial Ground formerly owned by the late William Heron, situate in the New Part of Ground near the corner of <u>George and Allen Streets</u>. Marked by Monument to the late William Joseph Heron. The above claimer thinks the lot was purchased by the late William Heron about twenty years ago."

Following my visit to my sister's home in Miramichi, New Brunswick, the next portion of my journey was to travel to Fredericton, York Co. for a visit with other relatives. During my stay in Fredericton, I arranged and appointment at the Provincial Archives of New Brunswick on the University of New Brunswick Campus.

Following my wonderful 'finds' in the archives, I made printed copies and saved the original documents to my USB memory device. Knowing where the loyalist Burial Cemetery was in downtown Fredericton, I decided to take a drive back into the downtown core of the city.

Arriving shortly thereafter, I parked the car just outside the back gate to the cemetery and decided to walk the rows in the hopes I might stumble upon. Fortunately, there were some men working in the cemetery in



The 1.6-acre property has plenty of toppled headstones, broken monuments, and rusting fences. It has been subject to extensive damage and vandalism over the years, and the city said, "it has fallen into disrepair."

I approached the team of restorers, working in the cemetery and asked them where I might obtain a map of the cemetery plots/graves. "It's your lucky day, Sir," he said.

He approached the tailgate of his truck and produced before my very eyes; a full map of the Old Loyalist Burial Grounds which was established in 1784.

He asked if I had a plot number and I replied, "yes," I told him, "Plot #29".

He immediately directed me to Plot #29 on the map and then pointed me in the right direction to the Heron/Savage/Tait gravesite. It was exactly where the source above mentioned; on the corner of George and Allen Streets, the southwest corner of the burial grounds.

From the PANB, I received a copy of James' Memorial, including his several references, attesting to his loyalty...

Memorial of James Tait UEL.

"He carried little or no property with him. No appearance of troubles in Virginia for a Year & - after he arrived which was in March 1774. He joined the British Army under Gen Arnold in 1781 & continued with the Army till he was made Prisoner at the Surrender of York Town. Says during his Continuance in the Country he rendered every Assistance in his power to British Prisoners. He was employed in Lord Cornwallis's Army as an Assistant in the Qur Mastr Gen Department from the time he joined the Army till its Surrended (sic) the Army. He addressed him & expressed his uneasiness at remaining in the Country & a wish to join the British Troops. Upon Col Dundas mentioning this his inclination to Gen Arnold the Gen expressed a wish that he should remain in the Country & make Drawings of the different roads Passes &c which Mr Tait agreed to do expressing a Desire to be of every service in his power to the British Troops. (?)s Exertions &c. Col Dundas says that the Paper which he produces contains as far as falls within his knowledge a very fair Account of his Conduct.

He came to England in 1783 & applied to the Treasury where he got an Allowance of $20 \pm a$ Year which he has received from Jan? 1783 & now continues to receive it. Says that Lord Dunmore advised him to stay in the Country & to conform to their Government to a certain Degree. He says he was sent for by a Magistrate in 1776 & 1777 to take an Oath, but he did not do it.

However, he obtained a Certificate that he did. And he says he was obliged to declare in all public Companies that he had taken the Oath. Since sooner or at any time. He never signed any Association paper. Says if he had been obliged to take the Oath or leave the Country, he thinks he should have left the Country.

Does not think that any Man could have stayed in the Province at that time without taking an Oath or getting such a Certificate as he did. Didn't swear till 1778 or 1779. Always swore Oath but that he had not in fact taken the Oath & believes he said true.

In another Source, E UNIVERSITY PRESS- the notes of Mr. Daniel Parker Coke, M.P., One of the Commissioners During That Period; Edited by Hugh Edward Egerton, BEIT Professor of Colonial History in the University of Oxford; Oxford, Printed for the Members of the Roxburghe Club, MDCCCCXV5, says

"...that in Virginia for a Year & - after he arrived which was in March 1774. He joined the British Army under Gen. Arnold in 1781 & continued with the Army until he was made Prisoner at the Surrender of York Town. Says during his Continuance in the Country he rendered every Assistance in his power to British Prisoners. "James Tait was a Virginian refugee who appeared before the loyalist compensation board when it convened in London in April of 1785. In his testimony before the commissioners, he recounted how he had drawn road maps for the royal army as he had expressed "a desire to be of every service in his power to the British troops". However, were it not for the testimonies of three witnesses, posterity would not know of how Tait had come to the aid of British prisoners of war and fellow Loyalists."
