## Loyalist Day 2015

At a recent Branch Executive meeting, several details were finalized about this year's Loyalist Day celebrations.

May 18, 2015 falls on Victoria Day this year and although many may hope to open their cottages after the long, dreary winter that we hardy New Brunswickers have endured, we're hoping to see many come out to honour our Loyalist ancestors.

The Loyalist Sunday Church Service will be celebrated at Stone (St. John's Anglican) Church on Carleton Street in uptown Saint John on May 17th. The service will start at 10:30 a.m. and we need to gather in the church hall by 10:15 am.

Steve Owens will be showing Loyalist images in a pre-service slide show. Following the service there will be a light brunch at nearby Loyalist House for those attending the service.

Loyalist Day morning ceremonies will go ahead as usual on May 18, the Victoria Day holiday, beginning at 10 am.

Saint Mary's band will provide a short concert and music throughout the ceremony, which includes the Queen Anne flag raising, the Loyalist Day proclamation read by the Town Crier, short addresses by local politicians and other dignitaries, and members of the UELAC-NB in period dress.

Plan to join us at Market Square atrium for this colourful event. We will very much miss the school children's attendance this year, due to the holiday, but we will send letters to the schools to ensure the 1783 Loyalist Landings and their significance are not forgotten. The 3rd Field Artillery will be busy with Victoria Day celebrations in Fredericton but will also be performing the 21-gun salute at noon at the waterfront in Saint John as in previous years.

The NB Museum and Loyalist House will be open to the public free of charge in the afternoon. Several UEL and NB Historical Society members will be at Loyalist House in costume to provide free tours of this fascinating home to so many Merritt generations from the original Loyalist, David Daniel, who built the house in 1810 - 1817, through to when it was acquired by the NB Historical Society in 1959. Plan to make a day of it in celebration of our Loyalist heritage.

The Loyalist Day Banquet will once again be held at the Union Club on Germain Street, Saint John on the evening of May 18.

This year's menu will include maple-glazed salmon and lemon mousse. A reception begins at 6:30 p.m., with the dinner following at 7:00 p.m. Robert Pichette, a renowned expert in heraldry, will be our guest speaker. ■

Notes of the Executive meeting held on 16 April 2015

Loyalist Day: Jim and Dave reported that arrangements are in hand. Invitation letters have gone out. The venue has been reserved — the ceremony will take place indoors. The 21-gun salute will take place at Pugsley Terminal. Very low attendance is expected. Loyalist House will be open following the 21-gun salute.

Loyalist Dinner: Deborah and Jim reported that sales are going well. It was agreed that Dave would introduce the speaker, Robert Pichette. There was some discussion about table decorations but no major changes from prior years are planned.

Church Parade: Will take place on 17 May at Stone Church. Members are asked to gather at 10:15 a.m. Loyalist House will be open following the church service and a brunch will be served. Members of the congregation will be invited to attend.

**Finances**: Jim reported on the Branch's financial situation. The bank account stands at around \$1400 after deducting outstanding cheques and amounts being held for the Loyalist Dinner. The investment account has a value of almost \$15000. The only major expenses on the horizon are the donation to St. Mary's Band and the painting & installation of Burial Site plaques.

**Memberships**: Renewals have slowed to a trickle. We now have 129 members (including other family members), a decline of 6 from last year.

**Burial Site plaques:** Dave reported that the 20 new plaques still need to be painted, which will happen soon. The selection of the 20 cemeteries to be marked is almost complete.

Annual General Meeting: Arrangements are in place for the AGM on 18 June. The main items of business will be the election of officers, the receiving of reports and the motion to increase the membership dues.

**Autumn meeting:** Deborah reported that the autumn meeting will take place on 15 October. Kate Waller will make a presentation entitled "Loyalist Women"

## Jacob Till, Loyalist?

It's probably been twenty years since I gathered the first bits of information about Jacob Till who, according to my hypothesis, is my 4g-grandfather in two different ways. During that time my search for documentary evidence about Jacob has been fitful.

Recently, however, having just finished another UE certificate application, I decided it was time to devote some real effort to the search for Jacob. He would be the basis for another application.

Where can I find the muster rolls for the regular British forces? What about the German units that served with the British?

I've long had documentary proof that my 2ggrandparents, Peters V. Laskey and Mary Matilda Till, married in 1846 in Lincoln, New Brunsick. I also knew that another 2g-grandfather, Alexander Haines, had married Catherine Till, a 2g-grandmother, in 1831 in Keswick Ridge, NB.

Some additional documents proved that Mary and Catherine were siblings — daughters of James Till and Nancy Ann Boone.

Information emerged showing James Till was born in Maugerville in 1789 and died in Geary in 1839 but I've never found any documents that would prove the connection to his father, Jacob.

Maybe I could prove James was a brother of William and William was a son of Jacob.

Proving that William was a son of Jacob was easy. William applied for a grant of some land that had originally been granted to Jacob and then escheated to the Crown.

In his petition William stated, "The before mentioned Jacob Tell, to whom the lot in question was originally granted, was the Father of your Petitioner, and he served during the American revolutionary War under the command of General Burgoyne, and was severely wounded and taken prisoner with that officer. That he came to this Province with the Loyalists at the evacuation of New York."

Not being a student of military history I decided to learn more about Burgoyne, in the hope that I could discover the name of the military unit in which Jacob had served. What I found threw a monkey wrench into my plan but also opened some interesting new avenues for research.

Turns out that Burgoyne's time in North America was relatively short. He led a group of British regular troops and German mercenaries into battle at Saratoga in October 1777 and was defeated. All of the soldiers serving under Burgoyne were taken prisoner.

Learning that Jacob Tell was either a regular British soldier or a German mercenary derailed the plans for another UE certificate application – as a regular soldier he would not qualify as a Loyalist. However, his origins still need to be researched. I need to find out where he came from.

This brings me to the point of this article. I need some help. Where can I find the muster

rolls for the regular British forces? What about the German units that served with the British? I sure hope I don't have to make a trip to the Public Records Office in the UK in order to complete my search.

# Spring Meeting

The first Old Home Week gathering was held in 1950, and was decided that it would be held again every five years. Tradition sees the event held the first week of August. 2015 marks 65 years since it all began, and will be held August 1<sup>st</sup> through 8<sup>th</sup>.

Sunday, August 2: Breakfast (St. George's Roman Catholic Church); Genealogy Center; Cemetery Service and Dedication; Quilt Show; Souvenir Sales; Blessing of the Fleet/Parade of Lights/Fireworks.

## Postscript

It is a truism in genealogical research that family myths, no matter how far-fetched, sometimes contain a grain of truth. In my family, for example, it was long said that we were related to the wealthy Vanderbilts of New York. So how come we were driving a ten-year-old car?

The Loyalist Collection at the University of New Brunswick contains microfilm of British, North American Colonial, and early Canadian primary sources from approximately 1740-1870. Reel #5 in this group contains information about Colonel Richard Lawrence Sr. (1729-1789), a 'Loyalist officer from Staten Island, New York'. Included are legal documents, diplomatic correspondence, genealogical information and personal papers, 1765-1840.

As it happens, this Richard Lawrence is my my g-g-g-grandfather. In our family bible there is a nineteenth-century entry for one Frances Lawrence, who is declared (in a fine copper-plate hand) to be the daughter of Colonel Richard Lawrence 'of Revolution Fame'.

Richard Lawrence was a ship-builder, not a soldier. He did, however, play a prominent role in pre-Revolutionary War Staten Island politics, and he openly avowed himself as a Loyalist.

In 1776, Sir William Howe appointed him Master-Carpenter of the Royal ship-yards on Staten Island, with the rank and pay of a Colonel in the British Army. He was given orders to seize vessels, timber and naval stores owned by the 'rebels', which apparently he did with a will.

By 1786, the tide of war had turned in favour of the Americans. Richard Lawrence was made a fugitive, and then arrested and tried at the suit of several persons whose property he had confiscated during the war. From prison in the city of New York, he prayed for the interposition of John Temple, the British Consul, who communicated with John Jay, American Secretary for Foreign Affairs, and the case was submitted to Congress.

Eventually he was released, and travelled to England to press his claims for compensation. He died there suddenly on May 26, 1789, at Eltham, Kent. A copy of his will, dated March 7, 1789 was

forwarded from England. His wife Elizabeth Oakley, who survived him by many years, received the pension of a Colonel's widow from the British government during her lifetime.

Elizabeth was his second wife, the widow of Captain Oakley of the *American* army. This marriage was not agreeable to either her family or to his, who were all strong Loyalists. Her family was opposed to her marrying one 'whose sympathies were so decidedly in favour of the English'. Two children were born of this marriage, William and Jane.

Richard, the eldest son of Colonel Richard Lawrence and his first wife Mary Leggett, went with many other Loyalists to Saint John in 1793. Some of his sisters went with him. Anne, the eldest daughter, had married in New York, Colonel Justus Erle, a Polish refugee. Their son was a celebrated physician in Saint John and lived to an advanced age. Richard Lawrence, Jr. died in Saint John on September 16th, 1846.

Frances Lawrence was Colonel Richard's third daughter. She married my g-g-grandfather Cornelius Ackerman in Fredericton, probably about 1786. At that time she was known as Frances Vanderbilt, having married John Vanderbilt of Richmond, Staten Island almost a decade previously. As a Vanderbilt she was one of the original grantees of Parrtown. Whether Frances was divorced, or widowed, or merely separated from John Vanderbilt by the fortunes of war is unknown at present.

Worn out and made ill by imprisonment,
Colonel Richard Lawrence died too soon to play
a part in the affairs of New Brunswick, and his
'Revolution Fame' survives mainly among his
scattered (but proud) descendants. ■
